## OUR ROADS CAN'T COPE WITH AN INCREASE IN TRAFFIC

IT BEGGARS BELIEF THAT THE COUNCIL WANT TO PUT LOGISTICS HUBS ALONG THE A580 AND A STRETCH OF THE M6 WHICH IS ALREADY AT FULL CAPACITY. THE IMPACT WILL BE FELT ON NEWTON, HAYDOCK, WINWICK, ASHTON, LOWTON, GOLBORNE AND BEYOND. RESIDENTS NEED TO BE AWARE THAT HGVS WILL ACCESS PARKSIDE VIA THE A49 FROM WINWICK LANE AND THERE'S NOTHING TO STOP THEM COMING THROUGH NEWTON. THERE ARE SEVERE TRAFFIC PROBLEMS ALREADY ON THE M6, A580, A49, A58 AND HAYDOCK ISLAND WHERE THE WAREHOUSE DEVELOPMENTS ARE GOING TO BE LOCATED. LOGISTICS TRAFFIC WILL DOMINATE THE ROAD NETWORK FORCING ESTABLISHED BUSINESSES TO RELOCATE. THIS WILL IMPACT ON THE LOCAL ECONOMY AND THE DIVERSITY OF JOB OPPORTUNITIES AVAILABLE IN THE LOCAL AREA.

#### AIR POLLUTION IS AN INVISIBLE KILLER

AIR POLLUTION IN ST HELENS IS RESPONSIBLE FOR ALMOST 100 DEATHS PER YEAR. POOR AIR QUALITY CAUSES CHRONIC ILL HEALTH AND CONDITIONS SUCH AS LUNG CANCER, 90% OF THE AIR POLLUTION IS CAUSED BY VEHICLE EMISSIONS. THE M6 AND A49 ARE AIR QUALITY MANAGEMENT ZONES BECAUSE THE AIR POLLUTION IS A HAZARD TO HEALTH, HOWEVER, THE COUNCIL HAVE NO PLANS TO MONITOR THE IMPACT OF INCREASED TRAFFIC FROM NEW DEVELOPMENT ON AIR POLLUTION OR THE SERIOUS RISK TO LIVES.

## GREEN BELT IS PROTECTED TO STOP URBAN SRAWL

GREEN BELT PREVENTS TOWNS MERGING TOGETHER, IT BRINGS THE COUNTRYSIDE CLOSER TO US AND PROVIDES A VITAL HOME FOR NATURE. BUILDING ON GREEN BELT IS VERY TIGHTLY CONTROLLED AND IS ONLY PERMITTED IN EXCEPTIONAL CIRCUMSTANCES TO ENSURE BROWNFIELD LAND IN URBAN AREAS IS THE FOCUS OF DEVELOPMENT. ST HELENS COUNCIL WANT TO GIVE DEVELOPERS VAST AREAS OF GREEN BELT LAND ON WHICH TO BUILD THEIR GIGANTIC WAREHOUSES. THE GREEN BELT IN NEWTON AND HAYDOCK WILL BE TOTALLY DECIMATED! "A GAP" WILL SEPARATE OUR TOWNS. IF THE GREEN BELT PROTECTION IS REMOVED, THERE WILL BE NOTHING TO PREVENT ANY TYPE OF DEVELOPMENT FROM BEING APPROVED IN FUTURE.

THE COUNCIL CLAIM THAT WE NEED TO DEVELOP OUR GREEN BELT TO CREATE LOCAL JOBS BUT WHAT THEY REALLY WANT ARE BUSINESS RATES FOR ST HELENS BOROUGH. A MASSIVE 90% OF THE LAND ALLOCATED FOR LOGISTICS IN THE NEW LOCAL PLAN IS IN NEWTON AND HAYDOCK. THE ECONOMIC STRATEGY FOR THE BOROUGH IS BASED UPON WAREHOUSING IN THESE TWO SMALL TOWNS. THE COUNCIL ALSO WANT THOUSANDS OF HOUSES BUILT ON OUR GREEN BELT TO CONVINCE THE GOVERNMENT THE COMMERCIAL DEVELOPMENTS ARE NEEDED! INCREASING THE POPULATION HERE WILL INEVITABLY PUT EVEN MORE PRESSURE ON OUR INFRASTRUCTURE AND OVER STRETCHED LOCAL SERVICES. JOBS ARE WELCOME BUT NOT AT ANY COST TO OUR HEALTH. WELL BEING AND ENVIRONMENT. OUR TOWNS WILL BE DOMINATED BY SPRAWLING LOGISTICS PARKS, SUFFOCATED BY EXHAUST FUMES AND THE ROADS GRIDLOCKED. THE IMPACTS WILL BE IRREVERSIBLE WITH SERIOUS CONSEQUENCES FOR FUTURE GENERATIONS.
